That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a first amendment to agreement with VICTOR WULFF, ARCHITECT, AIA & ASSOCIATES, for professional design services at various City parks and recreation facilities by amending that agreement on file in the office of the City Clerk as Document No. 756730 to provide an additional sum of \$98,300 for compensation, and reimbursement expenses, under the terms and conditions set forth in the form of first amendment to agreement on file in the office of the City Clerk as Document No. 757298.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer within the General Fund 100 the sum of \$98,300 from the Unallocated Reserve (53.31) to the Allocated Reserve (53.20) to be used solely and exclusively for the purpose of providing funds for the above purpose.
