WHEREAS, this City Council has determined that a new schedule of charges for public sewer connections should be established in order to reimburse City for all costs of material, labor, equipment and any other costs incidental to the performance of this service; and

WHEREAS, the City Manager, pursuant to San Diego Municipal Code, Section 64.13, has made his recommendations concerning said fee schedule; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That pursuant to San Diego Municipal Code, Section 64.13, the following fee schedule and rules shall be used for charging for City connections to public sewers:

CONNECTION TO PUBLIC SEWERS

WORK TO BE DONE BY WATER UTILITIES DEPARTMENT

FEES AND CHARGES ESTABLISHED

The owner or applicant for connection to the public sewers of the City of San Diego shall pay to the City for construction and laying of laterals the following charges:

SEWER CONNECTION CHARGES

Property Connection	\$15.00
Private Permit Connection (Encroachment or Easement)	25.00


Whenever an installation is required by an applicant, to be done by the City, such work will be done with charges based upon an estimate of costs made by the Department.

Installations may be done by others except for Property Connections and Private Permit Connections.

BE IT FURTHER RESOLVED, that Resolution No. 210050, which previously established sewer connection charges, be and it is hereby rescinded.
