WHEREAS, the Committee of One Hundred has offered to contribute \$50,000 to the City if the City will match said \$50,000 contribution and use the \$100,000 to refurbish the Spreckles Organ Pavilion in Balboa Park; and

WHEREAS, the Committee of One Hundred has indicated a willingness to attempt to raise an additional \$25,000 if the City approves in concept matching said additional \$25,000, which funds would again be used for refurbishing the Spreckles Organ Pavilion; and


WHEREAS, the Spreckles Organ Pavilion is suffering certain physical deterioration and requires work to maintain its structural integrity and the Organ Pavilion also lacks a suitable sound system and requires seating improvements; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that \$50,000 from the Facilities Reserve 223 Fund is hereby authorized to be set aside in a special fund and combined with \$50,000 to be received from the Committee of One Hundred and used for the refurbishing of the Spreckles Organ Pavilion in Balboa Park.

BE IT FURTHER RESOLVED, that the setting aside of another \$125,000 from said Facilities Reserve 223 Fund to be matched by an additional \$125,000 to be raised by the Committee of One Hundred for the purpose of refurbishing the Organ Pavilion is hereby approved in concept.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to work with the Committee of One Hundred to establish specific plans for the refurbishing of the Organ Pavilion which refurbishing will be done through the City by City Contract and/or City forces.
