WHEREAS, The City of San Diego is the owner of portions of Pueblo Lots 1106, 1107, 1173 and 1174 of the Pueblo Lands of San Diego; and

WHEREAS, R. E. HAZARD CONTRACTING COMPANY, a California corporation, owner of the adjoining property, has requested that the City convey to them City's interest in and to said portion of Pueblo Lots 1106, 1107, 1173 and 1174 to allow better utilization of the property; and

WHEREAS, said land has been determined to be surplus for all all City needs as long as the City retains an easement for sewer purposes; and

WHEREAS, the deed conveying said property will reserve an easement for sewer purposes; and

WHEREAS, the City desires to negotiate the sale of said land to R. E. HAZARD CONTRACTING COMPANY, under the provisions of Section 22.0902 (e) of the San Diego Municipal Code, which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such an interest in real property as this may reasonably be accomplished only by negotiation; and

WHEREAS, it has been determined by an independent fee appraiser that the value of the property is the sum of Seventy-Six Thousand,

Three Hundred Dollars (\$76,300); and

WHEREAS, no real estate broker's commission shall be paid and all costs relating to the sale will be borne by the applicant; and WHEREAS, the sale of the aforementioned property is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That that certain real property described in that form of grant deed on file in the office of the City Clerk as Document No. 757310, be, and the same is hereby authorized to be sold by negotiation for the sum of Seventy-Six Thousand, Three Hundred Dollars (\$76,300) to R. E. HAZARD CONTRACTING COMPANY, a California corporation.
- 3. That no broker's commission shall be paid by City on the herein described sale and all costs relating to the sale will be borne by the Grantee.

- 4. That the requirements of Council Policy 700-30 as to advertising and public notice are hereby waived.
- 5. That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
