RESOLUTION NO. 217120

WHEREAS, The City of San Diego is the owner of a portion of Section 1, Township 14 South, Range 4 West, San Bernardino Meridian, according to official plat thereof; and

WHEREAS, JOHN C. MABEE, owner of the adjoining land, has requested that the City convey to him all of the City's interest in and to said portion of Section 1; and

WHEREAS, said land has been determined to be surplus by the Property Director as long as the City retains an easement for water purposes; and

WHEREAS, the deed conveying said property will reserve an easement for water purposes; and

WHEREAS, the City desires to negotiate the sale of said land to JOHN C. MABEE, under the provisions of Section 22.0902 (e) of the San Diego Municipal Code, which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such an interest in real property as this may reasonably be accomplished only by negotiation; and

WHEREAS, it has been determined by a staff appraiser that the value of the property is the sum of One Thousand Five Hundred Dollars (\$1,500); and

WHEREAS, no real estate broker's commission shall be paid and all costs relating to the sale shall be borne by the applicant; and

WHEREAS, the sale of the aforementioned property is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

1. That that certain real property described in that form of grant deed on file in the office of the City Clerk as Document No. 757317, be, and the same is hereby authorized to be sold by negotiation for the sum of One Thousand Five Hundred Dollars (\$1,500) to JOHN C. MABEE, a married man, as his sole and separate property.


2. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed, the form of which is on file in the office of the City Clerk as Document No. 757317, granting to JOHN C. MABEE, as his sole and separate property, a portion of Section 1, Township 14 South, Range 4 West, San Bernardino Meridian, as more particularly described in said form of grant deed.

3. That no broker's commission shall be paid by City on the herein described sale and all costs relating to the sale shall be borne by the grantee.

4. That the requirements of Council Policy 700-30 as to advertising and public notice are hereby waived.

5. That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
