WHEREAS, it has been determined by a staff appraiser that the value of the property is the sum of One Thousand Five Hundred Dollars (\$1,500); and

WHEREAS, no real estate broker's commission shall be paid and all costs relating to the sale shall be borne by the applicant; and

WHEREAS, the sale of the aforementioned property is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 2. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed, the form of which is on file in the office of the City Clerk as Document No.

 granting to JOHN C. MABEE, as his sole and separate property, a portion of Section 1, Township 14 South, Range 4 West, San Bernardino Meridian, as more particularly described in said form of grant deed.
- 3. That no broker's commission shall be paid by City on the herein described sale and all costs relating to the sale shall be borne by the grantee.
- 4. That the requirements of Council Policy 700-30 as to advertising and public notice are hereby waived.
- 5. That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
