WHEREAS, the City Council considered the application of YVES and HEDDY DUVAL, owners, and CORONADO VIEW ESTATES, permittee, for a Conditional Use Permit for a mobile home park in the area of Highway 94, Kelton Road and 60th Street; and

WHEREAS, testimony and evidence was presented to and considered by the Council at a public hearing on November 10, 1976; and

WHEREAS, the City Council made the following findings:

- 1. The proposed facility will not contribute to the general well being of the neighborhood or community in that the best interests of the neighborhood would be served by construction of conventional housing.
- 2. The proposed use would be detrimental to the public health, safety and general welfare of personnel working or residing in the area in that the mobile home park will materially alter the pattern and stability of existing development.
- 3. The proposed use would comply with applicable regulations.
- 4. The proposed use would adversely affect the General Plan and Community Plan in that the mobile home park would not provide for a general benefit to the community because development would not relate to the surrounding community and become a part thereof; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the application of YVES and HEDDY DUVAL, owners, and CORONADO VIEW ESTATES, permittee, for permission under Conditional Use Permit No. 455-PC, to construct and operate a 152-space mobile home park with accessory facilities, parking, and landscaping, located south of State Highway 94, between Kelton Road and 60th Street, more particulary described as a portion of Lot 18, Rancho Mission of San Diego, C.C. 348, in the R-1-5 (portion in Hillside Review Overlay) Zone, be, and it is hereby denied.
