WHEREAS, Councilman Jim Ellis was recently elected to the Assembly of the State of California and has submitted his resignation as Councilman from the 7th District of the City of San Diego effective December 3, 1976; and

WHEREAS, pursuant to Municipal Code Section 27.3102, a special meeting was called to consider the question whether the vacancy should be filled by appointment by the City Council or by the process of a special election; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the appointment process set forth in Division 31, Art. 7, Chapter II of the San Diego Municipal Code (Section 27.3101 et seq.) is chosen as the method by which the vacancy shall be filled.
