


RESOLUTION No. 217139Adopted on NOV 17 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of FRANCISCA ALVAREZ, executed in favor of The City of San Diego, bearing date of July 23, 1976, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across portions of Lot A-78 and the unnumbered lot adjoining said Lot A-78 on the North, as per Map No. 1174 filed in the County Recorder's Office April 10, 1909, situated in San Ysidro, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named SMYTHE AVENUE.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
