That the acceptance by the City Manager of that deed of CAMERON BROTHERS CONSTRUCTION COMPANY, a partnership, executed in favor of The City of San Diego, bearing date of September 23, 1976, conveying to said City the permanent easement for the purposes of limiting and preserving in its natural state and as open space a portion of Pueblo Lot 1187 of the Pueblo Lands of San Diego, according to the Map thereof made by James Pascoe in 1870, as more particularly described in said deed, is hereby approved subject to the conditions expressed therein.

That the City Clerk is hereby authorized and directed to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the County Recorder of San Diego County.
