WHEREAS, the concept of regionalized lifeguard service has been under study by City and County Park and Recreation staffs since July, 1975; and

WHEREAS, the primary thrust of the study was concerned with the development of a consolidated regionwide lifeguard service with an equitable regional method for funding the service; and

WHEREAS, the City-County Task Force on Consolidation of Service and Facilities seeks to ascertain whether a contractual service agreement in lieu of outright consolidation is feasible; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be and he is hereby directed to negotiate with the County Chief Administrative Officer the detailed framework under which contract lifeguard services could be provided by the City which would:

a. Lead to the incentive for all jurisdictions in the region to participate in such a program;

b. Result in a general cost reduction for the region as a whole; and

c. Establish the basis for equitable financing and program control.

2. That the City Manager be and he is hereby directed to report jointly with the Chief Administrative Officer to the
