WHEREAS, the City of San Diego has entered into a contract with the U. S. Department of Housing and Urban Development (HUD) to carry out, within the City of San Diego, a Housing and Community Development Program; and

WHEREAS, the successful planning of community improvement programs in Southeast San Diego requires the use of Block Grant funds in the estimated amount of \$15,935; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:


1. That the scope of services, work program and budget as set forth in the document on file in the office of the City Clerk as Document No. 757374 be, and the same, are hereby approved.

2. That the City Auditor be and is hereby authorized to transfer the sum of \$15,935 from Block Grant Fund No. 290 to Redevelopment Fund No. 9836 as an advance to be repaid from tax increments or other project revenues.

3. That the City Manager or his designee is hereby authorized to expend the sum of \$15,935 from Block Grant Fund No. 290 for the purpose of implementing said study.
