

RESOLUTION NO. 217156

WHEREAS, The City of San Diego has entered into a contract with the U. S. Department of Housing and Urban Development (HUD) to carry out, within the City of San Diego, a housing and community development program; and

WHEREAS, the successful implementation of initial activity in the Dells Redevelopment Project requires the use of Block Grant funds in the estimated amount of \$2,044,643; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the scope of services, work program, and budget for the Dells Redevelopment Project as set forth in the document on file in the office of the City Clerk as Document No. 757366 be, and the same are, hereby approved.

2. That the City Auditor be, and he is, hereby authorized, for the purpose of implementing the Dells Redevelopment Project, to transfer the sum of \$567,773 from Block Grant Fund No. 2910 to Redevelopment Fund No. 9835 as an advance to be repaid from tax increment or other project revenues.

3. That the City Auditor be, and he is, hereby authorized, for the purpose of implementing the Dells Redevelopment Project, to transfer the sum of \$1,476,870 from Block Grant Fund No. 290 to Redevelopment Agency Fund No. 9835 as an advance to be repaid from tax increment or other project revenues.


