BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the offer of \$400,000 on behalf of The City of San Diego for the purchase of 60 acres in Crest Canyon and an offer of \$54,750 on behalf of the City of Del Mar for the purchase of 3.5 acres in Crest Canyon, as authorized by Resolution No. 76-60 adopted by the City Council of the City of Del Mar on October 4, 1976, a copy of which is on file in the office of the City Clerk as Document No. 757407, to National Pacific Development Corporation, a Delaware corporation, are hereby authorized.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$465,000 from the Environmental Growth Fund Reserve to CIP 20.006 and to expend said sum for the sole and exclusive purpose of providing funds for the acquisition of said property.
