That the offer of Motorola Communications and Electronics Inc. is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase and installation of RADIO COMMUNICATION EQUIPMENT as follows: forty-two (42) mobile radios at a cost of \$2,052.00 each; modify three hundred forty-five (345) existing mobile radios at a cost of \$181.00 each; furnish and install two (2) additional microwave channels at \$2,191.00 each; furnish and install one (1) console at a cost of \$16,819.00; modify one (1) existing console for \$1,482.00; plus a total of \$8,752.98 California Sales Tax, for a total cost of \$180,064.98; terms net 30 days less trade-in allowance of \$50.00 for one (1) base station; \$25.00 for one (1) remote control station, and \$30.00 each for eleven (11) mobile radios.
