BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby directed to install a traffic signal and safety lighting system at and in conjunction with the intersection of Ardath Road and La Jolla Scenic Drive North.

BE IT FURTHER RESOLVED, that the City Manager is hereby directed to install traffic signs prohibiting right turns from northbound Torrey Pines Road to eastbound on Glenbrook Way during appropriate hours as to be determined by the Transportation Design Division, said signing to be in place until the completion of the traffic signal installation at Ardath Road and La Jolla Scenic Drive North.

BE IT FURTHER RESOLVED, that the sum of Fifty-five Thousand Dollars (\$55,000.00) is hereby allocated from the Gas Tax Reserve Funds, and Ten thousand Dollars (\$10,000.00) is authorized from the Capital Outlay Reserve Fund for the purpose of installing the traffic signals at Ardath Road and La Jolla Scenic Drive North, said project to be added to the Capital Improvement Program and be entitled Installation of Traffic Signals at Ardath Road and La Jolla Scenic Drive North, and be designated CIP NO. 62-130.

BE IT FURTHER RESOLVED, that the Council hereby waives Council Policy No. 300-7 in order to allow the City Manager to immediately hire a consultant without the necessity of advertising for said services.

BE IT FURTHER RESOLVED, that the Purchasing Agent for the City of San Diego is hereby authorized to advertise for bids for the installation of the traffic signal and safety lighting system in connection with the intersection of Ardath Road and La Jolla Scenic Drive North.
