BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

1. That the Cultural Arts Program of The City of San Diego is deemed to be an activity that is necessary or appropriate to support the concentrated physical development activities being conducted within the former Model Cities neighborhood.
2. That the San Ysidro Schools Project that is operated by the San Ysidro School District and has been funded by The City of San Diego pursuant to the Demonstration Cities and Metropolitan Development Act of 1966 is deemed to be an activity that is necessary or appropriate to support the concentrated physical development activities being conducted within the San Ysidro area of the City.
3. That the Rehabilitation of Ex-Offenders Project is appropriate for inclusion in The City of San Diego Community Development Block Grant program as a service that is necessary or appropriate to support the physical development activities being conducted within the concentrated area of the former Model Cities neighborhood.
4. That the Senior Citizen Meals Program of The City of San Diego is deemed to be an activity that is necessary or
