RESUBDIVISION AND ACKNOWLEDGING RECEIPT OF
SUBDIVIDER'S ASSURANCE OF COMPLIANCE WITH THE
AFFIRMATIVE MARKETING PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by RONALD D. HOGAN, a Registered Civil Engineer, entitled
"PENASQUITOS GLENS UNIT NO. 7 RESUBDIVISION Being a subdivision
of Lot 342 of Penasquitos Glens Unit No. 7, in the City of
San Diego, County San Diego, State of California, according to
Map thereof No. 7004, as filed in the office of County Recorder
of San Diego County, July 30, 1971, together with portions
of Alamazon Street, as dedicated to public use on the Map of
Penasquitos Glens Unit No. 2, Map No. 6773 and on the Map of
Penasquitos Glens Unit No. 4, Map No. 6982.", is made in the
manner and form prescribed by law and conforms to the surrounding
surveys; that said map and the subdivision of land shown
thereon is hereby approved and accepted; and said Council hereby
accepts on behalf of the public, the following: Nawa Street,
Nawa Way, Nawa Court, Meknes Street and Meknes Way, for
public purposes; and said streets are hereby declared to be
public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, a municipal corporation, the
easement with the right of ingress and egress for the construction
and maintenance of drainage and sewer facilities as granted and
shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for open space, over, under, upon and across a portion of Lots 38 and 39, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that the easement with the right of ingress and egress for the construction and maintenance of of drainage and sewer facilities, together with the open space easement as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider H.G.H., a limited partnership, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 751410, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of PENASQUITOS GLENS UNIT NO. 7 RESUBDIVISION.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
