

RESOLUTION No. 217211Adopted on **DEC 8 1976**

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of PARDEE CONSTRUCTION COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of October 25, 1976, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across a portion of Section 30, Township 14 South, Range 2 West, San Bernardino Meridian, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named MENKAR ROAD.

That the City Clerk is hereby authorized and directed to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the San Diego County Recorder.
