

RESOLUTION No. 217212


Adopted on **DEC 8 1976**

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the petition for the construction of certain improvements of SORRENTO VALLEY ROAD from the N/E lot line of Lot 33B, Sorrento Lands & Townsite Maps #483 and #362 to the terminus of the old Sorrento Valley Road with I-805 adjacent to Lot 2 of said subdivision, under the provisions of the Improvement Act of 1911, consisting of one sheet and filed under Document No. 757543, is hereby granted.

That the City Manager be, and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the improvement of SORRENTO VALLEY ROAD, in the City of San Diego, by the grading of the roadway and the installation of a water main, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district to be included in the assessment for the work and improvements hereinabove mentioned.
