


RESOLUTION No. 217218Adopted on **DEC 8 1976**

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of the SAN DIEGO UNIFIED SCHOOL DISTRICT OF SAN DIEGO COUNTY, CALIFORNIA, executed in favor of The City of San Diego, bearing date of September 1, 1976, conveying to said City for public purposes a portion of Lot 42 of Horton's Purchase, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named IMPERIAL AVENUE; and the land therein conveyed as Parcel 2 is hereby dedicated as and for a public street and the same is hereby named 49TH STREET.

That the City Clerk is hereby authorized and directed to deliver said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
