
Adopted on _____

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That a portion of the Southeast Quarter of Lot 43 of a portion of the Ex-Mission Lands of San Diego known as Horton's Purchase, according to Map thereof No. 283 filed in the office of the County Recorder of San Diego County March 9, 1878, as more particularly described in the legal description attached hereto as Exhibit A and incorporated herein, be and the same is hereby set aside and dedicated as and for a public street and the same is hereby named IMPERIAL AVENUE.

That the City Clerk is hereby authorized and directed to deliver a certified copy of this resolution to the Property Director for further handling.

DEDICATION OF IMPERIAL AVENUE
OVER A PORTION OF LOT 43 OF A
PORTION OF THE EX-MISSION LANDS
OF SAN DIEGO

IMPERIAL AVENUE

All that portion of the Southeast Quarter of Lot 43 of a portion of the Ex-Mission Lands of San Diego known as Horton's Purchase in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 283 filed in the Office of the County Recorder of San Diego County March 9, 1878, more particularly described as follows:

Commencing at the Southeasterly corner of Lot 29 of Sunshine Gardens Map 1804; thence North $00^{\circ}49'24''$ East along the Easterly line of said Lot 29, a distance of 34.00 feet to the TRUE POINT OF BEGINNING; thence South $89^{\circ}18'28''$ East, 601.57 feet to the beginning of a tangent 20.00 foot radius curve, concave Northwesterly; thence Northeasterly along the arc of said curve through a central angle of $89^{\circ}48'34''$, a distance of 31.35 feet to a point of cusp with the Westerly line of 49th Street as located and established on the date of this instrument; thence South $00^{\circ}52'58''$ East, along said Westerly line, a distance of 14.02 feet to the beginning of a tangent 30.00 foot radius curve concave Northwesterly; thence Southwesterly along the arc of said curve through a central angle of $59^{\circ}55'41''$, a distance of 31.38 feet; thence North $89^{\circ}18'28''$ West along the Northerly line of Imperial Avenue as located and established on the date of this instrument, a distance of 85.03 feet; thence Southerly at right angles to the last described line, a distance of 4.00 feet; thence North $89^{\circ}18'28''$ West along said Northerly line of Imperial Avenue, a distance of 521.49 feet to said Easterly line of Lot 29 of Sunshine Gardens; thence North $00^{\circ}49'42''$ East along said Easterly line, a distance of 24.00 feet returning to the TRUE POINT OF BEGINNING.
