


**RESOLUTION No. 217222**Adopted on **DEC 8 1976**

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of THE SAN DIEGO UNIFIED SCHOOL DISTRICT OF SAN DIEGO COUNTY, CALIFORNIA, executed in favor of The City of San Diego, bearing date of October 12, 1976, conveying to said City an easement for public street or highway purposes across a portion of Lot 42, Horton's Purchase, in the Ex-Mission Lands of San Diego, according to Map thereof No. 283, filed in the office of the County Recorder of San Diego County March 9, 1878, as more particularly described in said deed, be and the same is hereby approved;, and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named 49TH STREET.

That the City Clerk is hereby authorized and directed to deliver said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
