APPROVING MAP OF AERO PARK SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by D. D. FARNSWORTH, a Registered Civil Engineer, entitled "AERO PARK Being a subdivision of Lots 1 through 5 inclusive of Mission Village Unit No. 24, according to Map thereof No. 7873, filed in the office of the County Recorder of San Diego County on February 21, 1974 and portions of Lots 10, 11 and 12 in Block 3 and portions of Lots 2 and 3 in Block 4 of Rosedale, according to Map thereof No. 826, filed in the office of the County Recorder of San Diego County, January 21, 1897, all in the City of San Diego, County of San Diego, State of California, together with Orange Avenue as closed and vacated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Castle Glen Drive, Corporate Court, Parcel "A," and the walkway for public purposes; and said streets and walkway are hereby declared to be public streets and a public walkway and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Castle Glen Drive, adjacent and contiguous to Lot 7, all as shown on this map within this subdivision and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and walkway are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
