RESOLUTION OF THE COUNCIL OF THE CITY
OF SAN DIEGO, CALIFORNIA, ORDERING A
CHANGE IN THE BOND DATE AND AUTHORIZING
THE ISSUANCE AND DELIVERY OF REDATED
BONDS.

(Standley Park Assessment District)

WHEREAS, in proceedings under the Municipal Improvement Act of 1913 (commencing with Section 10000, Streets and Highways Code), the Council on December 19, 1974 adopted resolution of intention, Resolution No. 212224, ordering the Superintendent of Streets to prepare the Report required by the Act and, pursuant thereto, the Report was made and filed; and

WHEREAS, the Council approved the Report, as filed, and appointed a time and place of hearing thereon and by Resolution No. 212226, adopted on December 19, 1974 invited bids for the purchase of the bonds to be issued to represent unpaid assessments; and

WHEREAS, notice of the hearing was duly published, posted, and mailed, the hearing was duly held and, at the conclusion thereof, the Council on January 30, 1975 ordered the project and confirmed the diagram and assessment and adopted Resolution No. 212539 awarding the sale of the bonds to Stone & Youngberg; and

WHEREAS, Resolution No. 212226 contained the form of notice inviting bids for purchase of the bonds, the notice fixing the bond date as the thirty-first day after the date of recordation of the assessment, such date of recordation being February 14, 1975 and such bond date being March 17, 1975; and

WHEREAS, the Council adopted Resolution No. 217096 proposing and declaring its intention to order the date of the bonds to be issued to represent unpaid assessments to be changed from March 17, 1975, as fixed by Resolution No. 212226, to September 17, 1976; and

WHEREAS, Resolution No. 217096 was duly published and mailed and the hearing on the proposed bond date change was duly held at the time and place fixed and all continuances, if any, were duly made and ordered; and

WHEREAS, at the hearing all persons desiring to be heard were fully heard and all oral and written protests, if any, were fully heard and this Council gave all persons present an opportunity to hear and be heard in respect to the proposed bond date change; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. Each and all oral and written protests and objections, if any, made or filed in the matter of the proposed bond date change are hereby overruled and denied.

Section 2. The date of the bonds to be issued to represent unpaid assessments is hereby ordered to be changed from March 17, 1975, as fixed by Resolution No. 212226, to September 17, 1976.

Section 3. The Treasurer is authorized and directed to issue and deliver to Stone & Youngberg, the bond purchaser, bonds dated September 17, 1976, all in accordance with the agreement between the city and the bond purchaser authorized and executed pursuant to Resolution No. 217095.
