

RESOLUTION No. 217252Adopted on **DEC 8 1976**


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the Council plans to donate the land shown on the designated map on file in the office of the City Clerk as Document No. 758162, to the State for addition to Torrey Pines Reserve and directs that staff expeditiously initiate the procedures for doing so.

The appropriate City departments shall include in all deeds or leases of Torrey Pines Science Park a statement that the property is within the Miramar Naval Air Station flight path and The City of San Diego has no present intention to seek or assist in any efforts to realign or relocate said flight path.
