

WHEREAS, The City of San Diego, a municipal corporation, is the owner of a parcel of land in the City of San Diego, **DEC 8 1976** County of San Diego, State of California, being a subdivision of portions of Pueblo Lots 1326, 1327, 1329, 1330 and 1334 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to the Map thereof made by James Pascoe in 1870, a copy of which said Map was filed in the office of the County Recorder of San Diego County, and known as Miscellaneous Map No. 36; and

WHEREAS, said City proposes to file a subdivision map of said area to be known as TORREY PINES SCIENCE PARK UNIT 2; and

WHEREAS, the Planning Commission of The City of San Diego has approved the final map of TORREY PINES SCIENCE PARK UNIT 2 subdivision, and has recommended to the City Council approval of said map; and

WHEREAS, it is necessary for THE CITY OF SAN DIEGO as a property owner to consent to the preparation and recordation of a final map thereof; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and City Clerk be, and they are hereby authorized and empowered to execute, for and on behalf of THE CITY OF SAN DIEGO, the certificate of ownership on said final map of TORREY PINES SCIENCE PARK UNIT 2 subdivision, consenting to the preparation and recordation of said map.
