That the bid of \$40,738.26 by Cofferdam Unwatering Corporation, a corporation, for the GEOHYDROLOGIC INVESTIGATION OF PAMO VALLEY for the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 756775.
2. That the expenditure of \$49,000.00 is hereby authorized out of the Water Revenue Fund (Fund 500) of the City of San Diego solely and exclusively for the purpose of providing funds for the GEOHYDROLOGIC INVESTIGATION OF PAMO VALLEY for the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$49,000.00 within Water Revenue Fund (Fund 500) from Unallocated Reserve-69.69 to Water Engineering Services - Operation and Maintenance - 69.46 for the GEOHYDROLOGIC INVESTIGATION OF PAMO VALLEY for the City of San Diego, and related costs.
