WHEREAS, there were relinquished to The City of San Diego certain abutter's rights of access in and to Churrituck Drive affecting a portion of Diamond Park, Map No.7034, filed in the office of the County Recorder; and

WHEREAS, the T.F.L. Co., a corporation, owner of the land, has requested that the City revest these abutter's rights of access in the property to allow better utilization of the land; and

WHEREAS, said abutter's rights of access are no longer needed by the City and should be revested in the property; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under city guidelines for implementation of said Act, as amended; and

WHEREAS, the City Manager recommends that said access rights be revested in the property; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of, The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 757582, to T.F.L. CO., a corporation, owner of said portion of Diamond Park, Map No.7034, effecting

the revestment of those abutter's rights of access to Churrituck Drive, heretofore relinquished to the City, more particularly described in said form of quitclaim deed.
