RESOLUTION NO. 217269

WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where that portion to be vacated has been superseded by relocation; and

WHEREAS, that portion of an alley adjacent to Lot 142, Northeast Clairemont Unit No. 2 has been relocated by the approval on this date of the dedication of a new alley alignment by the acceptance of the final map of the subdivision known as CLAIREMONT GREENS; and

WHEREAS, those properties adjoining that portion of the alley to be vacated will continue to have access or will be accessible by the streets which have been dedicated with the approval of the subdivision to be known as Clairemont Greens; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That a portion of the alley adjacent to Lot 142, Northeast Clairemont Unit No. 2, as more particularly shown on Drawing No. 13833-B on file in the office of the City Clerk as Document No. 757597, which said drawing is attached hereto and made a part hereof, be and the same is hereby ordered vacated.
