BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of PENASQUITOS, INC., an Illinois corporation, executed in favor of The City of San Diego, bearing date of October 15, 1976, conveying to said City for public purposes Lot 339 of Penasquitos Glens Unit No. 6, and Lot 270 of Penasquitos Bluffs Unit No. 3, as more particularly described in said deed, be and the same is hereby approved.

That the expenditure of \$600 from Building Permit Park Fee Fund No. 12141 and \$600 from Building Permit Park Fee Fund No. 12145 to cover escrow and title expenses for acquisition of the above described land is hereby authorized and approved.

That the City Clerk is hereby authorized and directed to deliver said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
