

RESOLUTION No. 217275Adopted on DEC 15 1976


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with HERMAN KIMMEL & ASSOCIATES, INC., a California corporation, for professional engineering services for design of traffic signal and safety lighting systems and major roadway widening at the intersection of LA JOLLA SHORES DRIVE and TORREY PINES ROAD and the intersection of NIMITZ BOULEVARD and WEST POINT LOMA BOULEVARD, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 757595.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is hereby authorized to transfer within Capital Outlay Fund 245 the sum of \$7,000 to Capital Outlay Fund 244 in an amount of \$3,500 to CIP No. 61-137(7) and \$3,500 to CIP No. 61-136(7) and further authorizing the expenditure of said funds to be used solely and exclusively for the above-referenced services.
