BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor and Comptroller is hereby authorized to transfer \$100,000 within Capital Outlay Fund 245 to Capital Outlay Fund 244, CIP 64-001(5), of The City of San Diego, and that expenditure of said funds is hereby authorized solely and exclusively for the purpose of providing funds for the purchase and installation of 3,385 miscellaneous traffic and street name signs at various locations city-wide.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary installation work in conjunction with the above-referenced project, pursuant to the recommendation of the City Manager and the submission of his estimates indicating said work can be done more economically by City Forces than if let by contract.
