RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DECLARING THE RESULTS OF THE CANVASS OF THE SPECIAL MUNICIPAL ELECTION HELD ON NOVEMBER 2, 1976 ON TWO PROPOSITIONS TO AMEND THE CITY CHARTER AND ONE LOW-RENT HOUSING PROPOSAL FOR LOW-INCOME PERSONS.

WHEREAS, this Council by Ordinances Nos. 11875 and 11879 (New Series) adopted August 11, 1976 and August 18, 1976, respectively, called a special municipal election to be held in the City on November 2, 1976; and

WHEREAS, this special municipal election was duly consolidated with the statewide primary election held upon the same date; and

WHEREAS, the special municipal election was held on November 2, 1976, for the purpose of proposing and submitting to the qualified electors of the City three propositions as follows:

PROPOSITION H:

PROPOSITION H. CITY OF SAN DIEGO CHARTER AMENDMENT. AMENDS SECTION 28 OF THE CHARTER OF THE CITY OF SAN DIEGO.

Relates to hiring of experts or consultants by the City Manager. Provides that the City Council shall establish by ordinance a dollar limit above which prior Council approval shall be required by the City Manager in order to hire experts or consultants when such assistance is necessary.

PROPOSITION J:

PROPOSITION J. CITY OF SAN DIEGO CHARTER AMENDMENT. AMENDS SECTION 94 OF THE CHARTER OF THE CITY OF SAN DIEGO.

Authority presently exists in Charter Sections 35 and 94 for the purchase of materials, supplies and equipment. This results in two procedures and creates ambiguity and inconsistency. This amendment deletes that language in Section 94 and provides that the purchase of all materials, supplies and equipment be governed by Charter Section 35.

PROPOSITION K:

PROPOSITION K. CITY OF SAN DIEGO LOW-RENT HOUSING PROPOSAL FOR LOW-INCOME OR ELDERLY LOW-INCOME PERSONS.

Do the qualified electors of the City of San Diego approve the development, construction and acquisition of low-rent housing projects within the City to provide not more than 2,500 dwelling units on scattered sites for living accommodations for low-income persons including but not limited to low-income elderly or low-income disabled persons?

WHEREAS, a canvass of the special municipal election has been completed and the City Clerk has certified the results to the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council finds and determines pursuant to the provisions of Section 27.2206 of the San Diego Municipal Code as follows:

- 1. The total number of votes cast in the City, including absentee votes, is 318,770.
- 2. The number of votes, including absentee votes, cast for and against each of the three propositions lettered H, J and K and the total number of votes cast upon each proposition, including absentee votes, are as follows:
