WHEREAS, The City of San Diego, California, has entered into a contract with the U. S. Department of Housing and Urban Development (HUD) to carry out, within The City of San Diego, a housing and community development program; and

WHEREAS, the City Council on October 9, 1975, by Resolution No. 214434, allocated funds for industrial development from The City of San Diego's Second Year Block Grant Program in the amount of \$2,090,000; and

WHEREAS, the successful implementation of industrial development projects in San Ysidro and Otay Mesa requires the use of Block Grant funds in the estimated amount of \$562,210; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the scope of services, work program and budget relating to the development of industrial facilities in San Ysidro and Otay Mesa as set forth in the document on file in the office of the City Clerk as Document No. 757618, be, and the same are hereby approved.

2. That the City Auditor and Comptroller is hereby authorized to expend the sum of \$562,210 from Block Grant Fund 290 for the above stated purpose.
