That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 757649 quitclaiming to LEXINGTON PROPERTIES, INC., a California corporation, that certain drainage easement in Pueblo Lot 1297, as more particularly described in said deed.
- 3. That no broker's commission shall be paid by City on the herein described negotiated sale.
- 4. That the City Clerk is hereby directed and authorized to file said deed and a certified copy of this resolution for record in the office of the County Recorder.
