

RESOLUTION No. 217291Adopted on DEC 15 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor and Comptroller be, and he is hereby authorized to transfer the sum of \$200,000 from Community Development Block Grant Fund No. 290, Program Element 87.95 (Contingencies and Unspecified) to Program Element 87.58 (Comprehensive Health Care Program) in order to provide total funds required to implement the Comprehensive Health Care Project.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized to execute, for and on behalf of said City, an agreement with the COUNTY OF SAN DIEGO for the purpose of continuing City support of activities leading to completion of the Comprehensive Health Care Facility for a period of twelve months from January 1, 1976 through December 31, 1976, and participate in one-third of the operational cost of the completed facility for a period of nine months from January 1, 1977 through September 30, 1977.
