WHEREAS, an application for transfer of eleven (11) certificates of public convenience and necessity from PLEASURELINE PRODUCTS, INC., dba La Jolla Cab Company, to MR. VIRGIL VANCE, dba La Jolla Cab Company, to operate taxicabs within the limits of the City of San Diego has been received; and

WHEREAS, pursuant to Section 72.0101(h) of the San Diego Municipal Code, the City Manager has caused an investigation to be made and has reported his findings in writing to this Council; and

WHEREAS, his report indicates, among other things, that the applicant, MR. VIRGIL VANCE, dba La Jolla Cab Company which is wholly owned by Mr. Vance whose character and fitness recommend him to engage in the business of operating taxicabs; and

WHEREAS, the Council this date has found the contents of the City Manager's report to be correct and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the transfer of 11 certificates of public convenience and necessity for taxicabs, as more particularly set forth above, be and it is hereby approved, subject to the following conditions precedent:

(1) That the transferee comply with all provisions of the San Diego Municipal Code.


