WHEREAS, the San Diego Police Department has been asked to participate with the American Justice Institute (AJI) in Phase II of the "National Project to Develop Police Program Performance Measures"; and

WHEREAS, the City and AJI would be co-recipients of a grant from the National Institute of Law Enforcement and Criminal Justice, Law Enforcement Assistance Administration (LEAA), United States Department of Justice; and

WHEREAS, the American Justice Institute will provide up to \$14,000 of the federal funds and up to 32 weeks staff time towards the implementation and testing of the police program performance measures in San Diego; and

WHEREAS, City will provide a maximum of \$80,167 in matching funds and the cooperation of staff members from the Police Department and other City departments in the collection of data required for measures computation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized to execute for and on behalf of City an agreement with the AMERICAN JUSTICE INSTITUTE for the purpose of developing police program performance measures, pursuant to the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No.

MICROFILMED MAY 3,1 1978 BE IT FURTHER RESOLVED, that City agrees to accept grant funds from AJI in an amount not to exceed \$14,000 and to appropriate \$53,747 in matching funds required by the grant.

BE IT FURTHER RESOLVED, that grant funds received hereunder shall not be used to supplant ongoing law enforcement expenditures.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to negotiate and execute necessary agreements for those contractual services specified in the grant contract.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer within the General Fund 100 the sum of \$53,747 from the Unallocated Reserve (53.31) to the Police Department, Planning and Research (15.05) for the current fiscal year, said remaining \$26,420 required for Fiscal Year 1978 to be included in the Police Department's Fiscal Year 1978 budget.
