RESOLUTION OF THE CITY COUNCIL APPROVING
PREMIUM OVERTIME STATUS FOR CERTAIN
DESIGNATED POSITIONS IN THE CLASSIFIED
SERVICE.

WHEREAS, Section 8 of the annual salary ordinance provides that classified positions determined to be eligible for premium overtime compensation shall be approved by resolution of the City Council prior to being officially designated in the Personnel Manual; and

WHEREAS, the Civil Service Commission determined at its regular meeting of October 7, 1976 that several positions warrant premium overtime designation; and

WHEREAS, said action of the Civil Service Commission is now recommended to the Council for approval pursuant to Section 8 of the salary ordinance; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Pursuant to the authority set forth in Section 8 of the fiscal year 1976-77 salary ordinance, the following positions in the Classified Service of The City of San Diego recommended by the Civil Service Commission for premium overtime status are hereby approved effective this date:

- Heavy Truck Driver II
- Senior Evidence Technician
- Maintenance Estimator
