


RESOLUTION No. 217303Adopted on DEC 21 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Where there is evidence presented to the Rules Committee that a community planning group has apparently floundered and there is need for an election to revitalize the community planning effort, the Rules Committee may recommend to the City Council that the open elector system will be employed, which will provide for as equal as possible representation from throughout the planning area.

BE IT FURTHER RESOLVED, that the City Council may request the Planning Department to investigate and report on the need for an election, after which the City Council may direct the City Manager to conduct an election.
