A RESOLUTION OF THE CITY COUNCIL AMENDING THE CAPITAL IMPROVEMENTS PROGRAM BY AMENDING DOCUMENT NO. 754397, AS AMENDED, TO ADD TO THE FISCAL YEAR 1977 PROGRAM A NEW PROJECT NUMBER 73-202, CONSTRUCTION OF SOLEDAD MOUNTAIN WATER PUMP PLANT, AND PROVIDING NECESSARY FUNDS FOR SAID PROJECT.

WHEREAS, in 1963 the Upper Soledad Area Charge was established to recover a portion of the cost of constructing the low pressure Bayview Pump Plant and discharge main; and

WHEREAS, said Area Charge was further intended to generate revenues for the future construction of the high pressure Soledad Mountain Water Pump Plant and appurtenant water facilities; and

WHEREAS, such funds so generated were deposited in Water Revenue Fund 502; and

WHEREAS, the Soledad Mountain Water Pump Plant is now scheduled for construction as a 1911 Act improvement project and the Water Utilities Department is requested to participate in said project in the sum of \$51,011, the total area charges collected to date; and

WHEREAS, the Water Utilities Department is being requested to further participate in the additional sum of \$15,961 so that sufficient funds are available for this project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That pursuant to Section 2, subsection 23 of the annual appropriation ordinance, the Capital Improvements Program as set forth in Document No. 754397, as amended, be and it is hereby further amended by adding C.I.P. Project No. 73-202, Construction of Soledad Mountain Water Pump Plant, to the Fiscal Year 1977 C.I.P. Program.
- 2. That the Auditor and Comptroller be and he is hereby authorized to transfer within the Water Utilities Fund 502 the sum of \$66,972 from the Unallocated Reserve (69.79) to C.I.P.-City Force and Contract (66.92) to provide funds for the above cited C.I.P. Project No. 73-202.
