


RESOLUTION No. 217349Adopted on **DEC 22 1976**

MATHER, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of October 5, 1976, conveying to said City a portion of Lot 22 of Moore's Subdivision, according to Map thereof No. 1300 filed in the office of the San Diego County Recorder December 21, 1910, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named PALM AVENUE.
