That the acceptance by the City Manager of that deed of GEORGE J. and ELIZABETH SCHNEIDER, husband and wife, and RICHARD G. and AZALEE WIGHT SCHNEIDER, husband and wife, executed in favor of The City of San Diego, bearing date of October 7, 1976, conveying to said City a portion of Lot 21 of Moore's Subdivision, according to Map thereof No. 1300, filed in the office of the San Diego County Recorder December 21, 1910, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named PALM AVENUE.
