BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and directed to enter into an amendment to agreement, for and on behalf of THE CITY OF SAN DIEGO, a municipal corporation, with MALONE-FINANCIAL SCENE, a joint venture composed of FINANCIAL SCENE, a California corporation, and VALENCIA VIEW, a partnership composed of the E. C. MALONE COMPANY, a California corporation and T. H. NIELSEN CORP., a California corporation, subdivider of VALENCIA VIEW UNIT NO. 1 subdivision, for participation in the construction of improvements on Valencia Parkway in said subdivision, and reimbursement by the City, all in accordance with the form of agreement filed in the office of the City Clerk as Document No. 757736.

BE IT FURTHER RESOLVED, that the additional expenditure not to exceed \$14,832.00 is hereby authorized out of Capital Outlay Fund 245, from the Annual Allocation, New Developments (CIP 58-001) of The City of San Diego, solely and exclusively for the purpose of providing funds for reimbursement to the subdivider of VALENCIA VIEW UNIT NO. 1 subdivision for the construction of improvements on Valencia Parkway.
