

RESOLUTION No. 217364


Adopted on DEC 22 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the COUNTY OF SAN DIEGO, for the purpose of funding one-third of the Releasee Aid Program, pursuant to the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 757696.

BE IT FURTHER RESOLVED, that the expenditure of \$26,666 in unexpended fiscal year 1976 Revenue Sharing Funds (Fund 265) of The City of San Diego, be and it is hereby authorized, solely and exclusively, for the purpose of funding one-third of the Releasee Aid Program.
