


RESOLUTION No. 217373Adopted on DEC 22 1976

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to Agreement with BROWN & CALDWELL, Consulting Engineers, to increase the maximum allotted compensation for consultant engineering services, under the terms and conditions set forth in the form of First Amendment to Agreement on file in the office of the City Clerk as Document No. 757898.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer within the Water Utilities Operating Fund 500 the sum of \$12,500 from Unallocated Reserve (69.69), Object Account 3495, to Water Engineering Services (69.46), Object Account 3293, for the sole and exclusive purpose of providing funds for the above services.
