

RESOLUTION NO. 217384

VACATION OF A PORTION OF NOB AVENUE, ADJACENT TO
BLOCKS 31, 32, 33 AND 56, DEL MAR HEIGHTS, MAP
NO. 157.

WHEREAS, it is proposed that a portion of NOB AVENUE, adjacent
to Blocks 31, 32, 33 and 56, Del Mar Heights, Map No. 157, be vacated;
and

WHEREAS, the street was dedicated at no cost to the public in
1890 per Map No. 157 and is fully improved consistent with the
surrounding community and there is no present or prospective use
for the excess right-of-way either for the public street system for
which the right-of-way was originally acquired or for any other
public use of a like nature that can be anticipated; and

WHEREAS, the public will benefit from the vacation through
improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with
the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way
was originally acquired will not be detrimentally affected by
this vacation as it has been deemed excess by City staff pursuant
to Council Policy 600-15; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
California, that a portion of NOB AVENUE, adjacent to Blocks 31,
32, 33 and 56, Del Mar Heights, Map No. 157, as more particularly
referred to in Resolution of Intention No. 217137, is
unnecessary for present or prospective public street purposes.

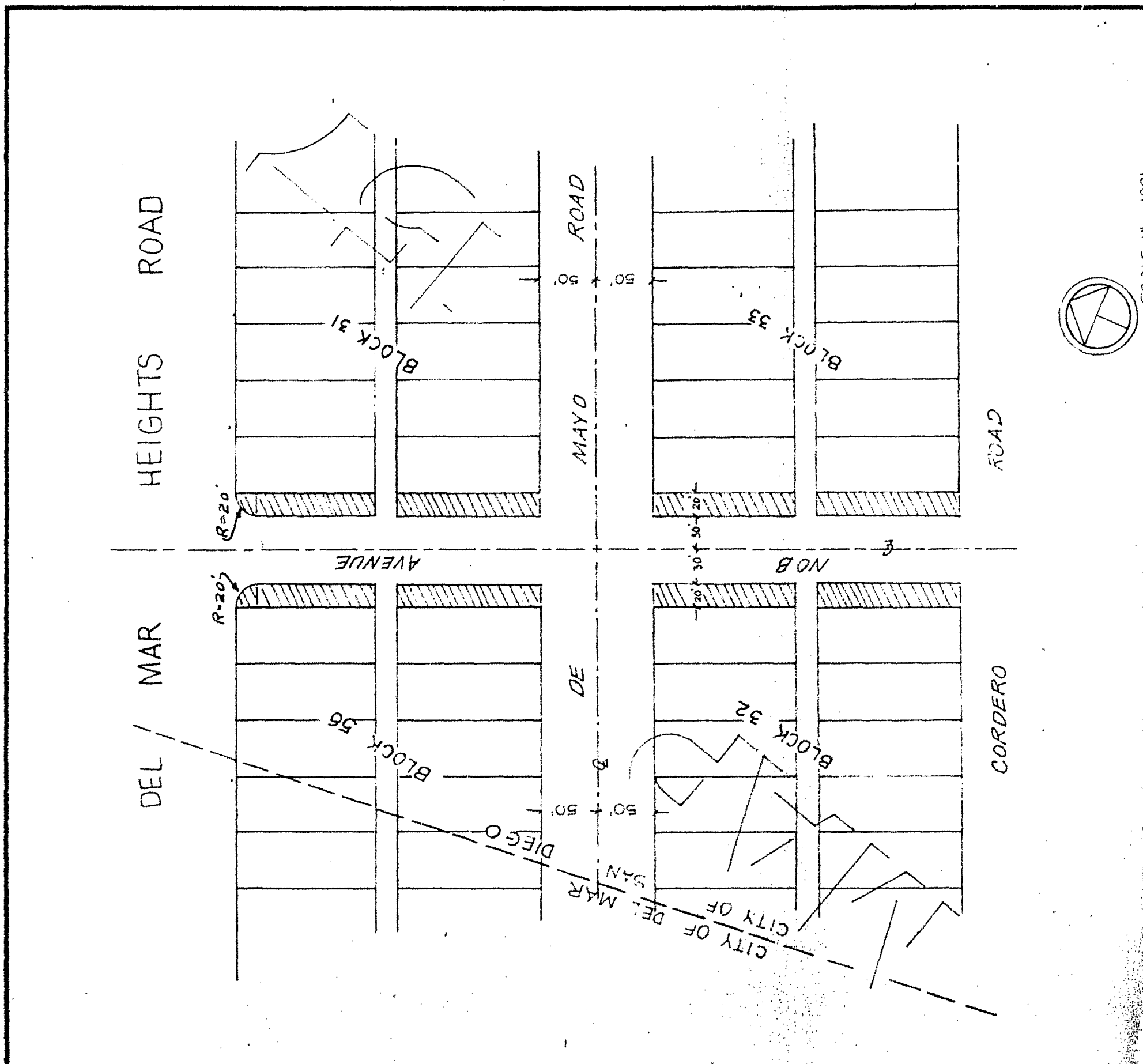
