

RESOLUTION NO. 217387

WHEREAS, a vacancy has occurred in the councilmanic seat of the 7th District of the City of San Diego by virtue of the election of the incumbent to the California State Assembly; and

WHEREAS, pursuant to the provisions of the San Diego City Charter and the San Diego Municipal Code this City Council has determined to fill said vacancy by appointment; and

WHEREAS, Joel M. Strobl has indicated his interest in an appointment to said vacancy; and

WHEREAS, Sections 3701(b) and 87202 of the California Government Code require the filing of financial statements by an appointee to a councilmanic seat ten days prior to his assuming office; and

WHEREAS, Joel M. Strobl filed the statements required by the California Government Code on December 8, 1976; and

WHEREAS, Joel M. Strobl has indicated that if appointed to the councilmanic seat of the 7th District he will not seek election to said councilmanic seat in the 1977 elections, as more fully reflected in a letter dated December 21, 1976 to the Mayor and City Council from Mr. Strobl, a copy of which is attached to this resolution as Exhibit "A"; and

WHEREAS, this indication by Joel M. Strobl is recognized by the City Council as a moral commitment; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to Section 12 of the City Charter and the




Dear Members of the Council:

As one of the two finalists in the Council's adopted selection procedure for the Seventh District vacancy, I have given a great deal of thought to the need for a compromise which will avoid an impasse.

I personally feel it is imperative that the Council avoid the undesirable necessity of an expensive special election, provide immediate representation to the constituents of the Seventh District, and eliminate the burden of double elections for potential candidates and their supporters.

Therefore, after careful consideration, I now offer to serve as an interim appointee, and pledge that I will not file nominating papers for the Seventh Council District in the September 1977 municipal primary.
