


RESOLUTION No. 217397

BE IT RESOLVED, by the Council of The City of San Diego as follows: *R77-1023*

1. That the bid of \$6,250.00 by John C. Fuller, an individual dba J. C. Fuller Landscape Const. for THE WATER MAIN REPLACEMENT AT DE ANZA COVE IN MISSION BAY PARK in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 757006.
2. That the expenditure of \$5,000.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) and that the expenditure of \$4,550.00 is hereby authorized out of the Park and Recreation Bond Fund Reserve (Fund 725) of the City of San Diego solely and exclusively for the purpose of providing funds for THE WATER MAIN REPLACEMENT AT DE ANZA COVE IN MISSION BAY PARK in the City of San Diego, and related costs.
